Chair McSherry explained that the *Community Safety and Policing Act* (CSPA) 2019 – Part IV, section (1) states that "a municipal board shall be known as (name of municipality) Police Service Board." Considering this legislative change, a Board motion is required to formally adopt the name change.

6.11 Report on Aggregate Disciplinary Measures in 2024

Chief Cobey explained that pursuant to section 205 of the *Community Safety and Policing Act, 2019, S.O. 2019, c. 1, Sched. 1*, this report is a new reporting requirement that had no prior precedent. Going forward, there will be two reports prepared for the Board on a semi-annual basis.

The report titled "Report on Aggregate Disciplinary Measures in 2024," and dated January 15, 2025, was received for information.

6.12 Chief's Monthly Update

Chief Cobey indicated that the Service will be hosting a second information session on Human Trafficking on January 20, 2025. The Guelph Police Service Strategic Plan specifically identified the need to ensure increased supports for victims and survivors of Human Trafficking and Intimate Partner Violence. This supports and is aligned with the unanimously passed motion by Guelph City Council in 2023 declaring Intimate Partner Violence an epidemic in the city. The Chief thanked the many organizations and community leaders who attending the first information session in the Fall of 2024. The Fall session was targeted to service providers, this event is targeted to members of the community. There has been excellent interest in the session and attendance for the session is at capacity. The Service will be hosting additional sessions moving forward in relation to Human Trafficking, Intimate Partner Violence, Internet Child Exploitation, and frauds often targeting Seniors.

Chief Cobey noted that Intimate Partner Violence and Human Trafficking are not developing issues. They are well established and require a concerted, collaborative and robust response.

The Guelph Police Service is one of six Ontario police services using a new provincial tool aimed at monitoring and sharing information about individuals on bail for firearms-related offences.

The new Provincial Bail Compliance Dashboard is managed by the OPP. Other participating services include Waterloo Regional Police, York Regional Police, Peel Regional Police and the Toronto Police Service.

The online dashboard provides map-based, near real-time critical information about charged persons released on bail for firearms-related offences. This new strategy permits the police to ensure those released on serious firearm-related offences are complying with their bail terms. If they are not, they are either charged or apprehended. In Guelph this would include those charged by the Guelph Police Service as well as those charged by other services but living in Guelph.

Chief Cobey invited Inspector Andrew Goody to provide the Board with an update related to the Downtown Safety Initiative.

In late October 2024, the Service deployed a team of five officers into the Downtown core to provide an increased presence focusing on public safety and enforcement. These additional resources were solely designated to the Downtown, and are to specifically address public safety, including open drug use and associated criminal behaviours. When lawful grounds existed, arrests have been made, and drugs have been seized. Officers would then follow the directions as set out in the *Controlled Substances Act* which directs officers to consider the appropriate course of action including warning, referral, or the laying of charges.

Throughout this initiative, one of the primary responsibilities of this team during any interaction was to ensure that the Service provide access to supports for those struggling with dependency.

Since the start of this initiative, the team has been deployed for more than fifty days of patrol through all areas of the Downtown.

Inspector Goody provided a quick summary of statistics from the initiative over the 50 days, including:

- Over 80 arrests occurred involving over 55 individuals (there have been some repeat offenders).
- Arrests have been for various criminal and drug related offences.
- More than 60 of these arrests were for open drug use or possession.
- Of these 80 arrests, approximately 50 charges were laid in total (only nine charged were laid in relation to drug related offences).
- Various quantities of illicit drugs have been seized. In addition, weapons, a stolen vehicle, and drug paraphernalia have been seized.
- Of the 80 individuals arrested, more than 50 were on some type of pretrial release order or on probation.

These statistics clearly demonstrate the efforts of the team to ensure public safety. Just as important is the ongoing support that these officers provide to those that they interact with.

The team has really focused on a health centred approach for this initiative, and for each interaction they had, each individual was afforded an opportunity to obtain help. The team has put an emphasis on assisting these individuals with getting the help that they need. The team has directly helped with access to detox programs, peer support, and medical assistance. More than 35 of the individuals were referred to support services through the IMPACT program or Welcoming Streets; some of the individuals already had access to support service; and more than 20 individuals who were arrested and released with a warning declined the help offered.

In the past few weeks, the Service has regularly heard from those who live or work in the Downtown that they greatly appreciate the efficient and effective work of this team. In conjunction with other Downtown resources, this team has significantly contributed to improving public safety. This is a clear demonstration of the effective service that can be provided when appropriate resources are allocated.

- C. Guthrie thanked Insp. Goody and noted that the feedback that he has received has been overwhelmingly positive in the last couple of months. The outpouring of thanks and positivity to the atmosphere in the Downtown is in many cases directly attributed to taking the safety of the Downtown core seriously.
- P. Allt asked if there has been any correlation between what has been initiated in the Downtown with what has occurred where people have moved i.e. in the periphery, along the river, etc. Insp. Goody noted that there was never an intention that the Service would eradicate open drug use, so it does occur elsewhere in the city. The Service has not been informed of any excessive drug use in other areas of the city. The Service still continues to work with other community partners to ensure that those who have moved away from the Downtown are able to access support.
- C. Guthrie asked if the closure of the encampment in the Downtown core has contributed to less drug activity, human trafficking, violence, and other issues that were happening there. Chief Cobey noted that there is certainly correlation between the timing of the Service's initiative and the encampment closure.

Chief Cobey mentioned that this initiative, as well as other investments that have been made (i.e. BEAT team and Drug session) have really demonstrated that when these investments are made, a strong return on investment can be realized.

Chair McSherry thanked Chief Cobey and Inspector Goody for the update.

RECOMMENDATION:

THAT the Guelph Police Service Board approves an amendment to the user fee charged for special duty administration, changing the fee to a 10 percent fee on total costs per day from a \$35.00 fee per day.

REPORT:

In accordance with Guelph Police Service policy AI-006, Special Duty, which states that the Chief of Police is responsible for setting the administration fee charged for Special Duty functions, a recommended change to the fee is being made.

The current fee is \$35.00 per day and is a flat fee regardless of the complexity of the special event. The proposed new fee is a 10 % fee on total costs per day. The percentage-based fee more accurately recovers fees based on value and complexity and therefore the change is recommended.
